

INSTRUCTION FOR AUTHORS

1. The Journal of Radiation Researches accepts original unpublished articles and book reviews in the following **fields**: - radiation research and its practical aspects, peaceful use of nuclear energy, nuclear physics, nuclear and radiation safety, radiochemistry, radiobiology, radioecology, application of nuclear and radiation technologies and methods, acquire and use of nuclear knowledge.
2. Articles have to be written in English. We would like to inform you that the articles should be submitted in Russian besides its English version.
3. The article should be sent either in the CD together with the signed statement or to the electronic mail (interproj-irp@yandex.ru) of the Journal. The submitted article should follow the following: article title, author's name, address, article abstract, list of key words, text including the results of the research and its significance and reference.
4. **File format** should be compatible with Microsoft Word formats in Times New Roman. The margins sizes of the page: - top 3cm, bottom 3sm, left 3sm, right 1.5sm. The article main text should be written in 12 point type size, single spaced. Articles should be submitted in triplicate, should be written in 12 point type size and typed on one side of A4 while article. The article title should be centered on the page and in bold capitals. The writer's name should be centered on the page under the article title with one space between the two, followed by the author's email.
5. The maximum number of pages for an article should not exceed 10 pages.
6. **The abstract** should be written in English, Russian and Azerbaijani languages in 11 point type size, between 100 and 150 words. The abstract of the article should correspond to the context of the article. The conclusion of the research, innovation and practical importance of the article should briefly be noted in the abstract by the author (s). In the abstract, the name of the article and the full name(s) of the author(s) should be written clearly.
7. **The keywords** should not be more than six words.
8. **PACS** alphabetical index should be used in the article.
9. **Figures, pictures, graphics and tables** must be of publishing quality and inside the text. Figures, pictures and graphics should be captioned underneath, tables should be captioned above.
10. **References** should be given in square brackets in the text and listed according to the order inside the text at the end of the article. Where applicable, author(s) name(s), journal title/book title, chapter title/article title, year of publication, volume number/book chapter and the pagination must be present.
11. The decision to publish a given article is made by the international review board of the journal through recommendations taken from referees. The referees may ask the author of the article to make amendments to the article prior to publication.
